**Amended Notice of Application
and
Notice of Written Hearing
Electricity Generation Licence - Raleigh Wind Power Partnership
EB-2009-0151**

Raleigh Wind Power Partnership has applied to the Ontario Energy Board for an electricity generation licence. The granting of this licence would enable the applicant to generate electricity in Ontario. The application includes a proposed wind generation facility with an installed capacity of 82.5 MW and is located in the municipality of Chatham Kent, Raleigh Township, Ontario.

The application will be decided by an employee of the Board who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*. The employee does not intend to provide for an award of costs when deciding this application.

This Notice is amended in order to reflect revised dates for participating in the hearing process.

How to participate in the hearing

The application will be decided by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. If you object to a written hearing for this application, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant by August 18, 2009.

If you wish to participate in a written hearing, you must forward three paper copies, and if possible, an electronic copy in Word format and searchable PDF format, of your written submission on the application, to the Board and one copy to the applicant. All submissions must be received by August 21, 2009. If the applicant wishes to respond to the written submissions, such response must be filed with the Board and copied to any party that made submissions by August 26, 2009.

All submissions must quote file number EB-2009-0151 and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
